**ADULT VOLUNTEER AGREEMENT AND RELEASE**

*Please read before signing, as this constitutes the agreement as a volunteer and the understanding of your working relationship as a volunteer Ravenswood Community Services (RCS), including All Saints' Episcopal Church (ASC).*

acknowledge and state the following:

I have chosen to volunteer to feed hungry people, mentor young people and make a difference in the neighborhoods of Uptown and Ravenswood.

I understand this work entails a risk of physical injury and involves physical labor, heavy lifting and other strenuous activity. I certify that I am in good health and physically able to perform this type of work.

I understand that engaging in this activity involves certain risks, not all of which are foreseen. I am volunteering at my own risk. I assume all risk and responsibility for any damage or injury to my property or any personal injury, which I may sustain while volunteering, and related medical costs and expenses.

I understand that RCS and ASC are not responsible or liable for my personal effects and property and that they will not provide lock up or security for any items. I will hold them harmless in the event of theft or for loss resulting from any source or cause. I further understand that I am to abide by whatever rules and regulations may be in effect during my service.

By my signature, for myself, my estate, and my heirs, I hereby release and discharge, and agree to defend, indemnify and forever hold harmless RCS and ASC and its officers, directors, agents, volunteers, servants and employees, from any and all causes of action arising from or relating to my participation in this project, including any damages including but not limited to claims for personal injury, sickness or loss of limb or life, even if said claims arise from injuries or illnesses caused by the sole negligence or fault of those hereby released.

I understand the need for confidentiality and will not discuss, photograph or otherwise disclose identifying information about the neighbors seeking help from RCS/ASC without prior permission from RCS, including any reference to names, addresses, or other identifying information.

I may choose to participate in additional activities on multiple or later dates, and this Volunteer Agreement and Release will apply to any activities in which I participate in the future. I hereby certify that I am at least 18 years old.
